CHAPTER 3-400. AIR POLLUTION CONTROL PROGRAM.

- § 3-401. Delegation to Air Pollution Control Board and the Department of Public Health.
- (1) The Air Pollution Control Board is hereby authorized to adopt by regulation an air pollution control program that is [no less stringent, and no more stringent, than] at least as stringent as the requirements of the Commonwealth of Pennsylvania Air Pollution Control Act (Act of January 8, 1960 (1959 P.L. 2119, No. 787) as amended) (the "Act") and the Federal Clear Air Act, 42 U.S.C. Section 7401 et seq., and rules and regulations promulgated pursuant to to those acts. Such program shall include, but not be limited to, the following:
