RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deeds conveying conditional fee simple title to 606 West Diamond street, 1221 North Taney street, 2719 and 2721 North Twelfth street, 814 North Sixteenth street, 1434 North Twenty-fourth street, 1332 North Twenty-ninth street, 110 West Glenwood avenue and 612-614 North Tenth street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
