Amending Title 14 of The Philadelphia Code relating to "Zoning and Planning," by amending Section 14-1612 entitled "South Street/HeadHouse Square Special Services District Controls," by extending the said controls to conform with City Council Ordinance (Bill No. 010069, approved June 14, 2001), under certain terms and conditions.

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 14-1612 of The Philadelphia Code is amended to read as follows:

TITLE 14. ZONING AND PLANNING.

\* \* \*

CHAPTER 14-1600. MISCELLANEOUS.

\* \* \*

§14-1612. South Street/Headhouse Special Services District Controls.

\* \* \*

(3) District Boundaries. For purposes of this section, the South Street/Headhouse Square Special Services District regulations shall apply to:

(a) all properties within the area depicted on Map “A” and Map “B”; and

(b) *all properties fronting on Kenilworth Street and Bainbridge Street between 3<sup>rd</sup> Street and Reese Street; all properties fronting on 4<sup>th</sup> Street between Bainbridge Street and Christian Street; all properties fronting on 5<sup>th</sup> Street between Bainbridge Street and Fitzwater Street; and, all properties fronting on the easterly side of Randolph Street between Fitzwater Street and Kenilworth Street.*

SECTION 2. This Ordinance shall take effect immediately.
