## CHAPTER 9-3900. PROPERTY LICENSES AND OWNER ACCOUNTABILITY

§ 9-3901. General Provisions.

\* \* \*

(6) Exemptions. Properties owned and operated by the Philadelphia Housing Authority and its subsidiaries in compliance with the Department of Housing and Urban Development federal property maintenance standards are exempt from all licensing requirements set forth in §9-3902 ("Rental Licenses") and any related fees. The ownership, operation and rental of such properties shall be exempt from all licensing requirements set forth in § 19-2602 of the Code pertaining to commercial activity licenses.
