## RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

<u>SECTION 1</u>. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title 3628 & 3728 Brandywine street and 4222 Powelton avenue pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

<u>SECTION 2.</u> The Philadelphia Redevelopment Authority is hereby authorized to dispose of the aforementioned properties for rehabilitation and/or improvements under certain terms and conditions pursuant to Chapter 16-
