SECTION 1. The Commissioner of Public Property on behalf of the City of Philadelphia is hereby authorized to lease to the Rosemary Montagno Senior Center, Inc., premises located at 12601 Townsend Road, pursuant to terms substantially set forth in the document attached hereto as Exhibit "A".

SECTION 2.
