(2) Standards for Rates and Charges: Pursuant to Section 5-801 of the Charter, the Water Department shall fix and regulate rates and charges for supplying sewage disposal services, without further authorization of Council, in accordance with the following standards:

(f) Special rates and charges, to be designated as "public housing sewer rates and charges" shall be established for property of the Philadelphia Housing Authority and shall be set so that the Philadelphia Housing Authority receives a [five] *twenty five* percent [(5%)] (25%) reduction off of the Water Department's service and quantity charges.
