Authorizing the City Solicitor, on behalf of the City, to enter into a multi-year contract with a provider of codification and editing services to produce printed and electronic versions of the 8th edition of The Philadelphia Code and periodic supplements, all under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The City Solicitor is hereby authorized to enter into a contract with a provider of codification and editing services to produce printed and electronic versions of the 8th edition of The Philadelphia Code and periodic supplements. Such contract may be for a term in excess of one year, but not for a term in excess of four years. The City's total annual payment under the contract shall not exceed \$40,000. The City Solicitor shall include in such contract such other terms and conditions as he deems necessary or appropriate in the interests of the City.
