SECTION 1. Section 2 of an Ordinance (Bill No. 970818) approved April 13, 1998 is hereby amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [within two (2) years from the date this Ordinance becomes law] by April 13, 2003.

SECTION 2. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00), toward the costs thereof, is paid into the City Treasury within sixty (60) days after this Ordinance becomes law.
