SECTION 1. Section 19-1301 of The Philadelphia Code, entitled "Real Estate Taxes," is hereby amended to read as follows:

§19-1301. Real Estate Taxes.

* * *

(8) A tax is hereby levied on each one hundred dollars (\$100) of the assessed value of taxable real property returned by the Board of Revision of Taxes in the preceding year at the rate of three (3) dollars and forty-seven and four-tenths (47.4) cents for the year 2003 and thereafter.

SECTION 2. Section 1 of this Ordinance shall be effective only if and when the tax authorized by Section 19-1801 of The Philadelphia Code is imposed by the School District of Philadelphia at a rate of three dollars and eleven and one-half cents (\$3.115) on each one hundred dollars (\$100) of assessed value of taxable real property, and only if the School District imposes said tax at said rate on or before June 30, 2002.
