Amending Section 9-205 of The Philadelphia Code, relating to Sidewalk Sales by restricting the prohibition of sidewalk sales on that portion of the south side of 900 West Nedro Avenue beginning, and extending east, from the south side of 1000 West Nedro Avenue for a distance of seventy-seven feet, ten feet from the curb.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-205 of The Philadelphia Code, relating to sidewalk sales, is amended to read as follows:

§9-205. Sidewalk Sales.

* * *

(8) Prohibited conduct. No person or vendor shall:

* * *

(p) exhibit, display, offer for sale or sell any goods, wares or merchandise or place or allow any stand to remain on the sidewalks of the following streets or any other location which Council shall from time to time ordain:

* * *

(.354) The area bordered by and including both sides of Olney avenue, Cheltenham avenue, Broad street and Fifth street, except that sidewalk sales shall be permitted on the south side of Medary avenue from the southeast corner of Broad street to a point seventy feet east from the southeast corner of Broad street, *and on the south side of West Nedro avenue from Tenth street to a point seventy-seven feet east from Tenth street.*

SECTION 2. This Ordinance shall take effect immediately.
