## THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 12-203 of The Philadelphia Code, the following one-way regulations are hereby established:

- (a) Paul Street, between Church Street and Meadow Street, Northbound.
- (b) Meadow Street, between Frankford Avenue and Tackawanna Street, Eastbound.
- (c) Tackawanna Street, between Gillingham Street and Church Street, Southbound.

- (d) Worth Street, between Church Street and Orthodox Street, Northbound.
- (e) Pear Street, between Tackawanna Street and Mulberry Street, Westbound.
- (f) Gillingham Street, between Mulberry Street and Worth Street, Eastbound.
- (g) Josephine Street, between Church Street and Kinsey Street, Northbound.
- (h) Blair Street, between East Montgomery Avenue and Norris Street, Northbound.
- (i) East Montgomery Avenue, between Blair Street and Frankford Avenue, Westbound.

SECTION 2. All existing parking regulations on the following streets are hereby terminated:

Paul Street, between Church Street and Meadow Street, East side.

SECTION 3. This Ordinance shall take effect upon replacement of parking signage consistent with this Ordinance.
