Amending Bill No. 090212 (approved May 27, 2009), entitled "An Ordinance to adopt a Capital Program for the six Fiscal Years 2010-2015 inclusive," by revising and adding certain projects, amounts and sources. *THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:* 

SECTION 1. Section 1 of Bill No. 090212 (approved May 27, 2009) is hereby amended to read as follows:

SECTION 1. A Capital Program for the six Fiscal Years 2010 to 2015, inclusive, nine-hundred-fifty-three totaling seven billion million eight-hundred-ninety-one thousand (7,953,891,000)seven billion nine-hundred-sixty-four million two-(7,964,291,000)hundred-ninety-one thousand dollars estimated in costs, is hereby adopted as set forth in the attached Exhibit A.
