SECTION 1. The City Solicitor is hereby authorized to enter into a contract with a provider of codification, editing, and marketing services to produce printed and electronic versions of the 11th edition of The Philadelphia Code, a Zoning and Planning Supplement and the 2015 Reprint of The Philadelphia Home Rule Charter, with periodic supplements to each. Such contract may be for a term in excess of one year, but not for a term in excess of four years. The City Solicitor shall include in such contract such other terms and conditions
