RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

<u>SECTION 1</u>. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deeds conveying conditional fee simple title to 1243 North Dover street pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

<u>SECTION 2.</u> The Philadelphia Redevelopment Authority is hereby authorized to dispose of the aforementioned property for rehabilitation and/or improvements under certain terms and conditions pursuant to Chapter 16-400

of The Philadelphia Code.

<u>SECTION 3.</u> The City Solicitor is hereby authorized to prepare or to approve all instruments and documents and to include in such instruments and documents such terms and conditions as are necessary to effectuate the purpose of Chapter 16-400 of The Philadelphia Code.
