THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 1 of Bill No. 210320 (approved June 28, 2021) is hereby amended to read as follows (matter added by amendment is in **bold**; matter deleted by amendment is in ~~strikeout~~):

SECTION 1. A Capital Program for the six Fiscal Years 2022 to 2027, inclusive, totaling nine billion, four hundred and ~~seventy four million, eight hundred and forty one thousand~~ **seventy-six million, six hundred and fifty-six thousand** dollars (~~(\$9,474,841,000)~~ **(\$9,476,656,000)**) in estimated costs, is hereby adopted as set forth in the attached Exhibit “A.”

SECTION 2. Exhibit A of Bill No. 210320 (approved June 28, 2021) is hereby amended to incorporate the following changes:

1. Under the “OIT” category, immediately after the “Capital Projects” project, increase the appropriation for the following project:
