The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 827 & 901 West Indiana Avenue pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.
