THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 3 of an Ordinance (Bill No. 090840) approved September 1, 2010, is hereby amended to

read as follows:

SECTION 3. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00) is paid into the City Treasury [within thirty (30) days after this Ordinance becomes law] *by March 31, 2011.*
