- (a) Licensee shall maintain the sidewalk cafe in accordance with all City, state and federal laws, as well as any rules and regulations which pertain to the use of the sidewalk cafe including, but not limited to, any and all City Code rules and regulations as may be required by the Department of Fire, Police, Health, Streets and Licenses and Inspections.
- (a) All food served from sidewalk cafes in the following locations shall be served on non-disposable containers, and no sidewalk cafe shall be maintained in the following locations unless such cafe is directly abutting a restaurant where more than twenty-five percent (25%) of the interior gross floor area is used for seating:
  - (.1) Chestnut street from Broad street to Eighteenth street; and
