Authorizing the revision of lines and grades on a portion of City Plan No. 44-S by striking from the City Plan and vacating Tenth street from Pattison avenue to a point approximately eight hundred forty-six (846) feet northwardly therefrom, and by placing on the City Plan Hartranft street, at a point approximately eight hundred forty-six (846) feet northwardly from Pattison avenue, extending from Tenth street to Darien street, under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 11-405 of The Philadelphia Code, the Board of Surveyors of the Department of Streets is authorized to revise the lines and grades on a portion of City Plan No. 44-S by:

- (a) Striking from the City Plan and vacating Tenth street from Pattison avenue to a point approximately eight hundred forty-six (846) feet northwardly therefrom.
- (b) Placing on the City Plan Hartranft Street (eighty-eight feet wide), at a point approximately eight hundred forty-six (846) feet northwardly from Pattison avenue, from Darien street to Tenth street.
- (c) Hartranft street from Darien street to Tenth street, owned by the City, is hereby declared to be legally open.
- SECTION 2. The Department of Streets is directed to record the opening of Hartranft street on its record.
- SECTION 3. This authorization is conditional upon confirmation by the Board of Surveyors.
