THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 2 of an Ordinance (Bill No. 080279) approved April 28, 2008, as amended by an Ordinance (Bill No. 100220) approved May 12, 2010, is hereby further amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [by April 28, 2012] by April 28, 2014:

SECTION 2. This Ordinance shall not become effective unless the sum of two-hundred dollars (\$200.00), toward costs thereof, is paid into the City Treasury within one-hundred twenty (120) days after this Ordinance becomes law.
