RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 2413 North Bouvier Street, 3217 Cecil B. Moore Avenue, 2922 West Fletcher Street, 1232 North Hollywood Street, 2535 North Hollywood Street, 2147 North Natrona Street, 1522-24 Parrish Street, 256 Richmond Street, 1851 Wylie Street, 2536 North Fifteenth Street and 1902 North Twenty-third Street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
