WHEREAS, the Act provides for continuing oversight of and assistance to the City by the Pennsylvania Intergovernmental Cooperation Authority (the "Authority"); and

WHEREAS, the Act calls for the City and the Authority to enter into an Intergovernmental Cooperation Agreement, setting out the respective rights and responsibilities of the parties; and

WHEREAS, the Act requires that any such Agreement is subject to approval by this Council; now, therefore,

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The Mayor, or such other officer of the City as the Mayor shall designate, is hereby
