THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 2 of an Ordinance (Bill No. 980717) approved March 23, 1999, is hereby amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [within one (1) year from the date this Ordinance becomes law] *by December 31, 2000.*
