WHEREAS, an Ordinance (Bill No. 070504), approved July 3, 2007, was conditional upon certain requirements being complied with within two (2) years from the date of approval; and

WHEREAS, it is desirable to extend the timeframe in which such conditions may be met; **NOW, THEREFORE**,

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 2 of an Ordinance (Bill No. 070504) approved July 3, 2007 is hereby amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [within two (2) years from the date this Ordinance becomes law] *by July 3, 2011*:
