**WHEREAS**, it is desirable to extend the timeframe in which such conditions may be met; **NOW, THEREFORE**,

***THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:***

**SECTION 1.** Section 2 of an Ordinance (Bill No. 070504) approved July 3, 2007 is hereby amended to read as follows:
