THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 11-403 of The Philadelphia Code, the Board of Surveyors of the Department of Streets is authorized to revise the lines and grades on a portion of City Plan No. 27-S by:

- (a) Striking from the City Plan and vacating the legally open portions of Dilworth street from Wolf street to Ritner street.
- (b) Striking from the City Plan Ritner street from Dilworth street to Weccacoe avenue.
- (c) Vacating Martin street from Weccacoe avenue to a point approximately two hundred eighty-one (281) feet southwestwardly to its terminus.
- (d) Vacating Greenville street from Weccacoe avenue to Dilworth street.
