RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying fee conditional simple title to 3013 West Fontain Street, 1842 West Ingersoll Street, 1221 & 1223 West Lehigh Avenue, 1307 & 1309 West Letterly Street & 1735 West Thompson Street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.

SECTION 2. The Redevelopment Authority is hereby authorized to dispose of the aforementioned
