THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-613 of The Philadelphia Code is hereby amended to read as follows:

CHAPTER 9-600. SERVICE AND OTHER BUSINESSES.

(1) Definitions.

(a) \* \* \*

(b) Utility cover. A cover made of metal or similar material that secures an area on the street or sidewalk in connection with gas, electric, water or other utility service.

\* \* \*

(3) Prohibited Conduct. No junk dealer shall handle, store, buy, sell, sort, pick or otherwise process any utility cover.

[(3)] (4) Penalties and Cease Operations Orders. \* \* \*

SECTION 2. This Ordinance shall become effective immediately.
