**WHEREAS**, an Ordinance (Bill No. 060317), approved September 28, 2006, was conditional upon certain requirements being complied with within two (2) years from the date of approval; and

**WHEREAS**, it is desirable to extend the timeframe in which such conditions may be met; **NOW, THEREFORE**,

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

**SECTION 1.** Section 2 of an Ordinance (Bill No. 060317) approved September 28, 2006 is hereby amended to read as follows:

**SECTION 2.** This authorization is conditional upon compliance with the following requirements [within two (2) years from the date this Ordinance becomes law] *by September 28, 2010:*

**SECTION 2.** This Ordinance shall not become effective unless the sum of two-hundred dollars (\$200.00), toward costs thereof, is paid into the City Treasury within one-hundred twenty (120) days after this Ordinance becomes law.
