Amending Section 20-101 of The Philadelphia Code, entitled "Residence Requirements," by clarifying that temporary residence outside the City, including for military service or educational purposes, does not prevent a person, including a police recruit, from meeting the Residence Requirement.

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 20-101 of The Philadelphia Code is hereby amended to read as follows:

§20-101. Residence Requirements.

(1) No person shall be appointed as an employee in the civil service of the City unless he or she has been a bona fide resident of the City for at least one year prior to his or her appointment. *A bona fide resident of the City for at least one year prior to leaving the City for military service or attendance at a post-secondary educational institution shall be deemed to meet the residency requirement if he or she resumes bona fide*

*residence in the City within six months of completing the military service or post-secondary education.*
