## RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deeds conveying conditional fee simple title to 1412 and 1415 West Dauphin street, 1417 North Myrtlewood street, 1710 West Seybert street, 940 West Silver street, 1128 Wallace street, 2118-20 Diamond street, 1100 West Glenwood avenue and 1935 and 1937 West Turner street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
