Amending Title 9 of The Philadelphia Code, by amending Section 9-203 relating to Street Vendors, by prohibiting street vending in the 54<sup>th</sup> Ward; all under certain terms and conditions.

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Title 9 of The Philadelphia Code is hereby amended to read as follows:

TITLE 9. REGULATION OF BUSINESSES, TRADES AND PROFESSIONS.

CHAPTER 9-200. COMMERCIAL ACTIVITIES ON STREETS

§ 9-203. Street Vendors.

\* \* \*

(7) Prohibited Conduct. No vendor or person shall:

\* \* \*

(o) stop, stand or park [his] *their* vehicle, *service*, or conveyance for the purpose of selling any goods, wares, *services*, and merchandise on the following roadways:

\* \* \*

*(.9) The Fifty-Fourth Ward, which encompasses the area bounded by Cottman Avenue, Roosevelt Boulevard, and then Castor Avenue.*

SECTION 2. This Ordinance shall be effective immediately.
