WHEREAS, The City of Philadelphia consists of a diverse population including citizens of every age, ethnicity, religious background, income and education level; and

WHEREAS, City Hall and its public spaces are a resource that every citizen should have a right to access and enjoy; and

WHEREAS, The *Art in City Hall* program includes the use of art-exhibit display cases that occupy the common areas and hallways on the 2nd and 4th floors of City Hall; and

WHEREAS, The display cases are not available for use by all members of the public; and

WHEREAS, It would be reasonable and appropriate to allow art created by high school students and inmates to be displayed as part of the *Art in City Hall* program on an equal basis with other artists; and

WHEREAS, The 1% for Art Program has in recent years been allowed to languish and frequently is not enforced; and

WHEREAS, The City's *Mural Arts Program* has received national and international recognition for its success in beautifying neighborhoods and giving at-risk youth constructive alternatives to destructive behaviors; and
