SECTION 1. The Commissioner of Public Property, on behalf of the City of Philadelphia, is hereby authorized to convey a parcel of land with the improvements thereon, located at 921-27 Ellsworth Street, as more particularly identified by the shaded area on the map attached hereto as Exhibit "A."
