THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 12-918 of The Philadelphia Code is hereby amended as follows:

§12-918. Parking for Car Sharing Organizations.

(3) One or more parking spaces may be reserved for vehicles owned by car sharing organizations on each of following blockfaces, at specific locations to be designated by the Philadelphia Parking Authority:

- (p) Moyamensing between Tasker and Morris Streets, west side
- (q) Washington Avenue between 3rd and 4th Streets, south side
- (r) 10th Street between Carpenter and Kimball Streets, west side
- (s) 9th Street between Bainbridge and South Street, west side
