THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. 300 Red Lion Road (Tax Parcel No. 88-2-1744-00), from the existing zoning designation of G-2 Industrial as indicated on Map "A" attached hereto to the zoning designation of R-1 Residential as indicated on Map "B" attached hereto.
