vacating Forty-third street from Woodland avenue to Forty-second street, and by reserving and placing on the City Plan certain rights-of-way for drainage purposes, water main purposes, and gas main purposes, under certain terms and conditions," by extending the period for compliance with the authorization conditions therein. *THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 2 of an Ordinance (Bill No. 990754) approved December 24, 1999 is hereby amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [within one (1) year from the date this Ordinance becomes law] *by December 24, 2001.*

SECTION 2. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00), toward the costs thereof, is paid into the City Treasury within sixty (60) days after this Ordinance becomes law.
