*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 6 of an Ordinance (Bill No. 120519) approved June 21, 2012, is hereby amended to read as follows:

SECTION 6. This Ordinance shall not become effective unless the sum of two hundred dollars

(\$200.00), toward costs thereof, is paid into the City Treasury [within sixty (60) days after the date this Ordinance becomes law] *by December 31, 2012.*
