WHEREAS, It is imperative that there be a more efficient flow of information between the City and its residents so that requested land and property may be processed in a more timely manner; and

WHEREAS, There has been a delay in the past several years in the transfer of land and property to neighborhood individuals or organizations and community development corporations; and

WHEREAS, There has been a delay with small entrepreneurs or individuals, as well as large investors seeking to obtain land and property for business development and neighborhood development; and

WHEREAS, It is imperative that we enhance neighborhood growth by improving the transfer and sale of property and land; now therefore, be it
