*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Title 9 of The Philadelphia Code is hereby amended to read as follows:

### TITLE 9. REGULATION OF BUSINESSES, TRADES AND PROFESSIONS

\* \* \*

*CHAPTER 9-5700. PROHIBITION ON CERTAIN GAMBLING MACHINES AND SKILLS GAMES*

*§ 9-5701. It shall be unlawful for a business to operate any casino-style or skill game that accepts cash payment for the chance of a cash reward and is not otherwise regulated by the State of Pennsylvania.*

SECTION 2. Effective Date. This Ordinance shall take effect immediately.
