SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying fee simple title to 2946 "B" Street, 187 W. Birch Street, 1714 N. Bodine Street, 181 W. Cumberland Street, 2831 N. Darien Street, 2733 N. Hope Street, 3017 N. Leithgow Street, 2548 N. Mascher Street, 1652 Meadow Street, 407 W. Norris Street, 2511 & 2828 N. Orkney Street, 3460 & 3462 N. Philip Street, 1262 E. Pike Street & 3046 N.
