RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 622 West Annsbury street, 3112 West Dakota street, 2205 North Franklin street, 1512 West Seybert street (rear), 2501 and 2505 North Warnock street, 2127 North Woodstock street, 1615, 1629 and 1634 North Twenty-seventh street, 1725 North Twenty-ninth street and 2731 North Twenty-ninth street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
