Authorizing the paving of Reserve Boulevard, Tuscany Drive and Capri Drive, under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The Procurement Commissioner, pursuant to the provision of Sections 11-502 and 11-503 of The Philadelphia Code, is hereby authorized to enter into a contract for the paving of:

1. Reserve Boulevard from Twentieth Street westwardly to a right angle thence southwardly to Pattison Avenue.

- 2. Tuscany Drive from Pattison Avenue to Reserve Boulevard.
- 3. Capri Drive from Reserve Boulevard to the northerly side of Hartranft Street.

SECTION 2. In lieu of the provisions of Section 1, the party in interest shall file an agreement and bond with corporate surety, satisfactory to the Law Department and in an amount determined by the Streets Department, to cover the cost of the work required to completely pave Reserve Boulevard, Tuscany Drive and Capri Drive at his sole cost and expense in accordance with the specifications and requirements of the City of Philadelphia.

SECTION 3. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00), toward the cost thereof, is paid into the City Treasury within one hundred twenty (120) days after this Ordinance becomes law, and the Board of Surveyors confirms the placing on City Plan No. 46-S of Reserve Boulevard, Tuscany Drive and Capri Drive.
