To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Sanger Street, Tacony Street, Devereaux Street and the Delaware River. THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-103 of The Philadelphia Code, The Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Sanger Street, Tacony Street, Deveraux Street and the Delaware River, from the existing zoning designations indicated on Map "A" set forth below to the zoning designations indicated on Map "B" set forth below.

SECTION 2. This Ordinance shall take effect immediately.
