Amending Title 12 of The Philadelphia Code, by amending Section 12-2809 relating to Civil Penalties and Costs, to increase the civil penalty for violations of Section 12-1126 relating to Excessive Noise, and Section 12-1127(1), (2), and (3) relating to Excessive Idling of or Noise from Motor Vehicles.

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Title 12 of The Philadelphia Code is hereby amended to read as follows:

#### TITLE 12. TRAFFIC CODE

§12-2809. Civil Penalties and Costs.

(2) Any person violating the following provisions of Title 12 shall, upon a final finding of liability pursuant to this Chapter 12-2800, be liable for payment of the civil penalty indicated, in addition to the costs and fees set forth in subsection 12-2809(1):
