From 1989 to 1992, she was the Utility Financial Administrator for the Sewerage and Water Board of New Orleans. She spent ten years with the Orleans Parish School Board and she holds a Bachelor's of Science in Accounting from the University of New Orleans. She is a Certified Public Accountant and Certified Government Financial Manager; and
