WHEREAS, Mr. Lonie has served the citizens as an employee of the City of Philadelphia for over thirty -six years, beginning as an engineering aide with the Streets Department; and

WHEREAS, Mr. Lonie has been the manager of the Survey Bureau for the past eight years and in that capacity has written over two hundred pieces of legislation that have come before this Council; and
