SECTION 1. Section 4 of an Ordinance (Bill No. 030341) approved July 31, 2003 is hereby amended to read as follows:

SECTION 4. The permission granted to Johnny Mañanas Restaurant to maintain and operate an openair sidewalk café on the east footway of Midvale avenue shall expire without any further action by the City of

Philadelphia if Johnny Mañanas Restaurant has not entered into the Agreement and satisfied all requirements of the Agreement that are listed in Section 2 [within one (1) year after this Ordinance becomes law] by September 30, 2006.

SECTION 2. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00) is paid into the City Treasury within sixty (60) days after this Ordinance becomes law.
