RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 1734 Federal street, 1341 South Hicks street, 2059 McClellan street, 1911 Mountain street, 1252 Pt. Breeze, 2642 Sears street, 3634 & 3636 Wharton street, 2228, 2235 & 2236 Wilder street, 1225 South 18th street, 1412 South 19th street, 1801 South 23rd street, 1100 South 27th street, 1536 South 29th street and 2064-66 S. 71st street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
